The DCH family was saddened by the passing of Joe Kilps, a long-time member of the DCH Auxiliary. He was a wonderful example of kindness and compassion to our patients and employees for many years.

Joe Kilps had a long history with Daviess Community Hospital. He was born here on September 17, 1922, just nine years after the hospital began providing care to patients. He had been a volunteer at DCH since 2008 when his wife passed away.

Joe and his wife had four children, all of whom were born at Daviess Community Hospital in the 1950's and 1960's. Joe recalled that in those days, fathers were not allowed in the room and pictures were not allowed. He remarked that when his grandchildren were born here, circumstances were much different.

In 2013, Joe served on the 100th Anniversary celebration committee. He was glad to help with the planning and research that was done to find the oldest known living person who was born at our hospital. Much to his surprise, the committee discovered that Joe was the person they were looking for the whole time.

Joe was a valuable member of our auxiliary and a friend to all who worked with him at the hospital. He will be greatly missed.

To honor Joe in 2013 as the "Oldest Known Living Person Born at DCH", Daviess Community Hospital placed a special "footprint" medallion on our Cradle Wall located on the second floor next to our nursery.

ERIC'S LIFE WITH KIDNEY STONES

Eric Van-Hoose is no stranger to kidney stones and the pain that typically is a result of the body trying to pass them.

At 14 years old, Eric was rudely awakened by excruciating pain. "My brother was in the bunk bed below me and thought I was dying by the noise I was making," recalled Eric. "My parents laid me down in the backseat of our car and drove me to the local hospital where we lived in Kentucky."

The hospital kept Eric for three days while they performed x-rays and various tests. It was four years later while swimming with friends that Eric developed a "side ache" that progressively worsened. This time it was his friends who took him to the hospital, but his stay was brief before being sent home.

Now at age 40, Eric can trace an unusual back pain that began in 2018 as what probably was the early symptoms of the kidney stones that were removed this year. At times, the pain has been almost unbearable. His wife, Christina, is a therapist at the DCH CORE Center. She has tried several techniques to help relieve the pain.

For the last year, Eric's white blood cell count was high. Dr. Thomas Waits, Oncologist at Daviess Community Hospital, was researching the cause of the elevated count. Infection caused by the kidney stones ultimately was the result.

In June of this year, Eric came to the DCH Emergency Department with debilitating pain. He passed two stones (size 3 and 4) while in the ED, which immediately relieved the pain. He scheduled an appointment a few weeks later with Dr. Kris Gunn, Urologist at Daviess Community Hospital. After scans were performed, the results showed that stones were present in both of Eric's kidneys and surgery was necessary.

Due to the number of stones in his left kidney, and the size of one particular stone (size 9), Dr. Gunn recommended surgery on that side first. He explained to Eric that surgery can only be performed on one kidney at a time since the body needs one good kidney to perform bodily functions.

Two weeks after the first surgery, Eric returned to DCH to have the stones in the right kidney removed.

"I researched the procedure and actually watched a video of it online before the first surgery," said Eric. "It was very eye-opening as to the type of equipment that would be used to get to the stones and remove them."

"Eric is doing all the right things to reduce the likelihood of more stones," said Dr. Kris Gunn, Urologist at Daviess Community Hospital. "Unfortunately, hereditary or genetic conditions beyond his control may also cause recurrent stones."

"Even though none of my siblings have had kidney stones, my fear is still that I might pass this on to my kids," Eric explained. Kidney stones develop when salts or minerals build up in urine and form crystals. The crystals stick together and get bigger, eventually forming a hard mass called a stone. A 24-hour urine analysis can see if there are high levels of some things in the urine that might cause kidney stones. Urinary pH is also important, as some crystals are more likely to form when urine is too acidic (low pH) and others are more likely to form when it's not acidic enough (high pH).

The results, along with other tests like blood tests and radiology studies, can help doctors find the cause and location of the stones, and plan treatment that might help prevent more kidney stones. After treatment starts, another 24-hour urine collection can help show if it's working.

"I love that Dr. Gunn is so open and approachable with his bedside manner," said Eric. "He was very real and talked to me on my level."

Eric was very pleased with his surgery team and the staff who cared for him both times on our Med Surg unit. "Everyone was exceptional," he recalled. "They answered my call light immediately anytime I needed help or was in pain. To have them help me manage my pain leading up to surgery was a huge relief. David Qualkenbush, one of the nurses on the floor, was great to encourage and support me through my stay both times."

"Eric was in a lot of pain both times he was on Med Surg," recalled David Qualkenbush, RN. "I really enjoyed taking care of him, but I am glad for his sake that he is well enough now to not return to the hospital."

Eric and his family operate "Hoose Hill Farms", a flower and honey destination in Daviess County. There is an incredible amount of labor involved during the summer with watering and nurturing the flowers, vegetables and bees at their business.

"The farm would not have made it through this summer without my wife and daughters taking care of the chores for me," Eric explained. "I am so glad that after the second surgery, I was able to get back to the farm tasks and back to life without pain."

DCH SLEEP DISORDERS CENTER RECEIVES RE-ACCREDITATION

Daviess Community Hospital is pleased to announce that the American Academy of Sleep Medicine (AASM) has granted accreditation for a period of five years to the DCH Sleep Disorders Center. This accreditation includes all types of sleep testing, including in-center polysomnography (PSG), multiple sleep latency testing (MSLT), maintenance of wakefulness testing (MWT) and home sleep apnea testing (HSAT).

"The process began back in 2016 with our initial accreditation," explained Tracy Conroy, CEO. "We chose AASM over two other accrediting organizations because they truly are the sleep experts. We are pleased to be accredited once again this year."

In 2022, Valerie Roark and Dr. Anand Bhuptani, a Pulmonologist for DCH who is Board-certified in Sleep Medicine and serves as medical director for the DCH Sleep Lab, began a year long process of completing the reaccreditation process. The application requires many statistics, diagnosis codes, proof of hospital license, blueprints of the sleep lab and credentials for every physician and technician who is involved in the sleep program. Once the application is submitted, AASM replies with any corrective measures. When all corrective measures are resolved to the satisfaction of AASM, the facility is granted reaccreditation for a period of five years.

"This accreditation is huge for a hospital our size," remarked Conroy. "It speaks highly to Daviess Community Hospital and our commitment to providing the highest possible quality of care to the patients visiting our sleep center and doing so with both the patient and technicians safety foremost in our mind."



DAVIESS COMMUNITY HOSPITAL AWARDED MATERNAL HEALTH GRANT

Daviess Community Hospital announced today it has received a grant totaling \$579,944.00 from the Indiana Department of Health to improve maternal and infant health as part of the state's Health Issues and Challenges program. This program was established by the Indiana General Assembly in 2021 with funding from the American Rescue Plan Act. The additional funding was made possible through the Epidemiology and Laboratory Capacity (ELC) through the CDC.

The grant will help to expand the current Mobile Integrated Health program to address maternal health in Daviess County. Under this program, an additional community paramedic, nurse navigator, and three community health workers will work together with our existing Community Paramedic and Transitional Care Nurse Navigator.

With the implementation of this extension, DCH will focus on the following areas affecting maternal and infant health in Daviess County:

- Mental health and Substance Use Disorder treatment
- Hypertension Disorders
- Preconception, Conception, and Post-Conception follow-up for patients until the child is 18 months old
- Education regarding Sudden Infant Death Syndrome
- Safe Sleep
- Tobacco Cessation
- Car Seat Safety

"We are excited to have this opportunity in Daviess County and the surrounding counties! The Mobile Integrated Health Perinatal Grant gives us the chance to help mothers and babies with barriers to care or with advanced care needs." - Shawna O'Kelley

BABY NAVARAH'S EXTENDED STAY AT DCH

Brionna Gully was in her third trimester of her pregnancy when she began feeling nauseous and experiencing high blood pressure. Her lab results indicated that she had preeclampsia and the birth of her child would be sooner than expected. Due to concerns for mother and baby, Brionna's obstetrician, Dr. Jonathan Frances, made the decision to induce her labor.

On July 21, 2023, Navarah Elayne Taylor arrived, weighing only 4lbs and 5oz. Even though Navarah was born about 7 weeks premature, she did very well throughout her stay. She spent a small amount of time in the special care nursery on CPAP, for respiratory support. She also spent some time in the incubator to help keep her tiny body warm. This helped her to avoid burning calories to stay warm which she needed to gain weight.

"Thanks to the advanced training of the nurses and respiratory therapists of our Level II Nursery, we were able to keep Navarah here at DCH where she could be close to her mother and family," said Miranda Schneider, NNP-BC. "We are now able to provide bubble CPAP and other forms of respiratory support for babies born early or sick."

Brionna said, "Miranda and all of the staff provided great care and helped me with Navarah until she was able to go home."

Brionna was able to stay as a guest at the hospital the whole time that Navarah was a patient. She was able to be involved in her care, as well as being able to pump and give her breastmilk. Being able to keep Navarah close to home also allowed Brionna to still spend time with her two other small children.



ABOUT THE DCH LEVEL II NURSERY

In November 2021, the Maternal and Child Health Division at the Indiana Department of Health granted Daviess Community Hospital an Obstetric Level of Care II and Neonatal Level of Care II.

The certification is effective through November 22, 2024. Daviess Community Hospital must apply for recertification before the expiration of the current certification.

This designation means DCH is certified to provide care to appropriate high-risk pregnant patients and the Special Care Nursery is able to provide care for infants who are born premature or moderately ill (those that are at least 32 weeks gestation and weigh at least 3 pounds.)

Additionally, DCH's Level II nursery is certified to care for babies who have been released from a neonatal intensive care unit but aren't quite ready to go home.

"There are few things more special than having a baby," said DCH CEO Tracy Conroy. "Our skilled maternity staff is committed to providing a safe and caring environment for each mother. This certification reinforces the excellent care our OB team provides to our region, allowing area mothers to give birth close to home."
